16/110 Presentation by Louise Williams re Housing Survey

LW distributed updated housing report which showed a dominance of detached housing in Churt, average sale value £848,000. Level of affordable homes is good but 11 properties lost through Right to Buy scheme. House prices to income ratio is high. 27% of parishoners returned survey, mainly over 60's. Respondees happy with current growth rate in Churt reflecting gentle infill. Need for smaller 2/3 bed houses as people look to downsize. Once business premises lost to housing this will not be reversed. Affordable homes built to a very high standard. Strong design style in Churt. Adequate supply of local facilities. Parking an emotive issue, 42% own 2 cars or more. In summary there is a small level of need but other need will be hidden. Villages in Surrey becoming more 'elderly' with some people in their 30's and 40's still living at home. Cllr Christie asked what other parishes had done in terms of publishing survey results? Generally provide a summary with a link to the full report. Nothing allocated for Churt in Local Plan. Within settlement boundary cannot designate land for local people only. Right to Buy does not apply to

houses on Rural Exception Sites, thus preserving housing stock in perpetuity. Report could be updated every 3 years. Louise to attend Working Group meeting on 10 January 2017 and was asked to speak at Annual Assembly in April.
